President's Report: Melissa

Treasurer's Report: Janet

501c3 Status and taxes updateTax update- we have not gotten a response from IRS as of yet. This is change our status to public charity. Not a surprise due to what is happening in washington and we will be patient. We are hoping to have this rquest granted. This will allow us to file a one page 990 for tax purposes.

Janet sent completed financials for 2024. This will be the basis of the 990 that we will file. Janet would like to point out our finances do not balance. Lacy and Janet worked to find discrepancies. What we think is that when we wrote checks to people who sold tack did not cash the check we sent them. Melissa- thank you Janet for putting all the hard work and many hours put into this. You have went through the last four years and gotten us on track. Per Janet, we will need a list of equipment for funds usage. Once we get that we are in good shape and will wait for the IRS to respond.

GRANT STATUS & OPPORTUNITIES REPORT: Dee

Grant received 4,999.00 for wood hitching rails and wooden corals. Any changes to this plan needs to be approved by forest service.

Anything is needed anyone can think of? Per Melissa, more signage. Janet- replacing the bathroom at coyote meadows; Per Melissa that is not actually our district.

BCH Grant for \$1000 due March, and then another one in June/July.

Possible grants for sawyer and first aid class. Right now it is just Melissa who is certified. If 8 or 10 people sign up, there will be a cross cut field day. Per Melissa first aid is required for sawyer certification.

We are currently a 501c3, currently as a 'private foundation', but we requested a change in our status. This is what Janet has been working on. Per Dee, this one does not give to private foundations. There is another in the Fall.

Janet to Dee, regarding teton springs grant. Janet needs the information of the grant, amount, date and how we plan to use funds. Hitching rails at moose creek trailhead and N. leigh trailhead, as well as 2 corrals at N. Leigh trailhead.

Future...APPLY TO: Community Foundation Grant & BCHI Foundation Grant (first aid kit stuff) & NWSA wilderness stewardship fund & BCH of America Grant (wilderness first aid training)

Dee to make a Calendar for grant openings/deadlines for the Year of potential grants we can apply for. A good future reference for Board members going forward.

Calendar Planning Session

*Packin Hitches and Overnight Restraints Clinic for <u>members only</u> in May? No time for this. Otherwise, board discussed TTBCH overnight pack trips held <u>only at the trailhead</u> (not in the Backcountry with multiple herds present). Some board members think that pack trips overnight <u>in the backcountry camps</u> with 5-6 different herds in the field is unsafe. We have found more success being at trail heads. IF a pack trip is happening, there is great cause for doing a clinic of some kind. Janet- there could be a sign up of like 4 people. The first 4 people to sign up can go learn backcountry skills.

Most of the board agrees that the trailhead camping is the best idea. Then possibly look at doing a pack trip next year.

Overview of calendar-

- Tim to host in october maybe. Divide lake in june is great, Tim could do this in June. 6 miles in.
 Trailhead is in the prairie. Old line camp and can camp there too. Shoes are needed on horses!
 Maybe camp friday, ride saturday.
- Last weekend in June- finish bog bridge in Bitch Creek. Moose creek is really important-early
 July. Or build corrals in June. that way they would be available all season. Or flip flop these. We
 did moose creek June 16th last year.
- One hosted ride per month.
- July ? packing/hitching/ overnight restraints clinic. DEADLINE is here! Feb 14th. Need dates of Covered Events for Insurance BCHI (2 free covered).

<u>TTBCH Event options:</u> Public invited? BCHI to offer 2 free covered events. Members not covered. Need own insurance. Buy Equisure or Idaho ride at own risk law.

- 1) **Driggs fair trail challenge** August 3. Public attends. Do we want to host for the third year in a row? (Hapi Trails help?).
- 2) Llama Desense Clinic to be covered?? Members only or open to public? Limit number of people? Plan next month!

PAUL'S COMMENTS in his absence: Mac and I will discuss the desensitization clinic. We plan to do it on our property. We'll figure out a weekend that works. I think we should do the 1st one for members only as the number of horses we can accommodate are relatively small and we're just figuring out what a clinic would look like (but we'll figure out how many are realistic and get the number). As for charges, you guys can decide what is most appropriate and if its members only, we are cool with free. Sorry I can't be at the meeting but we'll figure all the above out.

- 3) Fremont AG days- patrick will likely do this again. Is it insurance covered by school?yes
- 4) Targhee kids camp- Paul will be doing this. GTR to have insurance? Paul's non-profit as separate entity hosting this? Janet & cynthia raised concern about TTBCH involvement -staying focused on our Chapter's mission; reminded to think of our mission and our focus on trails maintenance. What do members want from us; trails focus and education/outreach focus. Discuss.

PAUL'S COMMENTS in his absence: I will no longer be doing camp under the TTBCH banner. If they choose to have me back (GTR) I will be doing it privately under Wynfromere Farm (my LLC).
