### PRESIDENT'S REPORT: Melissa

-BCHI Sept Board of Directors mtg coming up. Lewiston, ID. 9 ½ hr drive plus hotel too far for us and too much money to attend meeting. We will zoom in (tim, melissa, others?) Calendar discussion: BCHI said if NO to calendar, then TTBCH would need to put together a proposal for a new fundraiser. Any major decision needs to be taken to the voting delegates in March by resolution. The Sept BOD BCHI meeting will be to discuss how to move forward with some ideas for new fundraisers. John from sawtooth chapter (microranch@outlook.com) was interested in finding new ideas, but that's the only chapter besides us; 14 chapters want the calendars. We said we would take 0 calendars when we were at the meeting in the spring. Our chapter is in a unique situation in that we have the tin cup fundraiser where we get funding from a community fund raising event, unlike other BCHI chapters. We are all full-time workers that are on the board and time is precious. Mostly our board ends up buying a calendars and not having time or desire to sell. Our board has voted to just pay BCHI. Issue is it costs more to produce calendars if less calendars are ordered to be printed. We empathize with the idea selling calendars raises money that is much needed for BCHI to run. Our chapter will write a check instead of selling calendars. We just need a dollar amount from BCHI. We can assist in the implications for the increased cost of not ordering calendars in the bulk BCHI order. Plus we are happy to write a check for our \$250 contribution that would come from the sale of those 50 calendars that we would've sold in the past.
